***** SPECIAL NOTES AND RULES WITH CUSTOMS *****

THE PALLETS OR PACKAGES NEED TO BE LABELLED WITH MAWB AND HAWB NUMBERS;

PLEASE RE-WEIGHT THE CARGO BEFORE ISSUING THE HAWB AND MAWB IN ORDER TO AVOID WEIGHT DISCREPANCY ON ARRIVAL, DELAYS ON THE CLEARANCE PROCESS AND PENALTIES (APROX USD360,00);

PLEASE MAKE SURE THAT ORIGINAL HAWB (ORIGINAL 2 FOR CONSIGNEE) IS COMING WITH THE CARGO, ONCE WITHOUT THE ORIGINAL, CNEE WON'T BE ABLE TO RELEASE THE CARGO FROM CUSTOMS;

SHIPPING DOCS (MAWB & HAWB) CAN NOT BE RUBBED;
PLEASE SHOW ON HAWB THE AIRFREIGHT CHARGES, ONCE IS NOT ALLOWED THE HAWB WITH AIRFREIGHT CHARGES AS AGREED.
